

Subject: - Quotation for Intellectual Property Registration and other IP related work for MAFSU, Nagpur

MAFSU, Nagpur invites sealed competitive quotations to empanel a firm to handle the Intellectual Property Registrations of MAFSU, Nagpur. The Scope of work which includes Searching, drafting, filing, hearing, and any other services required to obtain the IP registration and also for other related forms of IP in India. The selection and empanelment of the IP firm will be based on an internal evaluation process. The firms are requested to send their quotations (as per the format given in Annexure I) in sealed envelope to the MAFSU, Nagpur.

Terms and conditions

- 1. The quotation in prescribed format (Annexure –I) may please be submitted in the name of 'The Director of Research, Maharashtra Animal and Fishery Sciences University, Futala Lake Road, Nagpur 440 001' on or before 26/11/2025.
- 2. The rates and the various taxes applicable on it should be mentioned separately.
- 3. Attach a copy of GST Certificate or Declaration of GST Non enrolment and Pan card certificate.
- 4. Enclose firm registration certificate. The Firm must be registered in India with a minimum of three years of experience in the relevant field (enclose documentary evidence).
- 5. The Firm shall provide undertaking/ declaration confirming the absence of any conflict of interest (Annexure-II)
- 6. The firm should not have been blacklisted by any Central/State Government/Public Sector undertaking, Govt. of India and should not be involved in any major litigation that may have an impact of affecting or compromising the delivery of services.
- 7. The empanelment of firm shall be initially for one year from the date of supply order and it may be extended for another <u>one year</u> after satisfactory performance with the same terms, conditions and rates.
- 8. Mode of payment to the empanelled firm shall be as follows: 30% after filing; 30% after examination of reports and 40% after final grant of patent.
- 9. The University reserves the right to cancel quotation process at any given point of time.
